MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificate of Service Authority, respectfully states as follows:

- 1. On April 12, 1989, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide shared tenant services to Executech Services, Inc. (Executech) in Case No. TA-88-168. Executech's signed application states that Executech will provide annual reports to the Commission.
- 2. Executech did not file an annual report for 1998. Additionally, Executech's 1999 annual report form was returned by the post office as undeliverable. The Staff contacted the Missouri Secretary of State's office and was informed that Executech was administratively dissolved by the Missouri Secretary of State on July 23, 1990, due to its failure to file an annual report.
- 3. Executech has not filed a formal request to cancel its certificate. However, the Staff believes that Executech has violated the terms of its certificate by its failure to file an annual report. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 1999), which provides:

Any certificate of service authority may be altered or modified by the

commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no part requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Comm'n, 776 S.W.2d 494, 496 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel Executech's certificate of service authority to provide shared tenant service.
