- 1. On November 8, 2005, the Joint Applicants filed their Joint Application which initiated this case with the Missouri Public Service Commission ("Commission"). Appendix 2 to the Joint Application was a copy of the Asset Purchase Agreement ("Purchase Agreement") dated as of September 21, 2005, by and between Aquila and EDE.
- 2. The Joint Applicants have now entered into Amendment No. 1 to the Asset Purchase Agreement (the "Amendment"), a copy of which is attached hereto and made a part hereof for all purposes. Briefly stated, the Amendment provides for (i) the retention by Aquila of certain liabilities and obligations related to a former manufactured gas plant site which were to have been assumed by

the Buyer under the original Purchase Agreement; (ii) an increase in the base purchase price by an amount equal to \$1,000,000; and (iii) the inclusion of EDG in the definition of "Buyer" in the Purchase Agreement.
