

**SUPPLEMENT TO

Comes now NEXTLINK Missouri, Inc. (NEXTLINK) by and through counsel, and pursuant to the Commission's order of April 28, 2000 submits this in supplement to its motion for leave to file annual report out of time and its application for confidential treatment of annual report:

1. At the outset, NEXTLINK offers a clarification to its motion. The motion stated that the company attempted to file the annual report on April 18, 2000 and the filing was rejected. This was an error. The company attempted to file its annual report on **April 17, 2000**, and the filing was rejected. The Commission's April 28, 2000 order notes that April 15, 2000 fell on a Saturday and thus the actual deadline for filing was Monday, April 17, 2000. On April 18, 2000 the company received a check sheet from the Commission. The check sheet indicated that the company would be required to file a motion for permission to file its annual report out of time. A copy of the check sheet is attached.


2. The matter was brought to the attention of the undersigned counsel. After consultation, it was agreed that a request for confidential treatment of the company's financial statements would be filed in conjunction with the motion for leave to file the annual report out of

time.

3. It appears that the annual report was filed timely, and NEXTLINK asks the Commission to treat the same as timely filed, subject however to the company's application for confidential treatment of its financial statements.


