- 1. Laclede is a gas corporation and a public utility, operating as a distributor and seller of natural gas in the City of St. Louis, St. Louis County and various other counties in Eastern Missouri, with its principal office located at 720 Olive Street, St. Louis, Missouri 63101.
- 2. Laclede has an interest in this case, because Laclede is a customer of Panhandle Eastern Pipeline Company ("PEPC"), which Southern Union d/b/a/ Missouri Gas Energy proposes to acquire. PEPC is part of Laclede's upstream pipeline transportation network. PEPC connects to the Missouri Pipeline Company to deliver gas to Laclede's service territory. At this time, Laclede does not have sufficient information regarding the proposed transaction to determine what position, if any, it will take in this case.
