INFORMATIONAL FILING OF NEXUS COMMUNICATIONS, INC.

COMES NOW Nexus Communications, Inc., d/b/a Reachout Wireless ("Nexus" or the "Company"), pursuant to 4 CSR 240-3.570(3)(D), and makes this informational filing with the Commission. In support hereof, Nexus states the following:

- 1. On April 15, 2009, Nexus filed its Application for Designation as an Eligible Telecommunications Carrier ("ETC") in Missouri, seeking ETC designation solely to provide wireless Lifeline and Link Up service to qualifying Missouri consumers.
- 2. On August 26, 2009 the Commission issued its Order Granting Application for Eligible Telecommunications Carrier Status and Waiver of Regulations (effective Sept. 5, 2009).
- 3. On October 4, 2011, Nexus notified the Commission of the registration of its fictitious name, Reachout Wireless, under which it will be conducting business in Missouri.
- 4. Pursuant to 4 CSR 240-3.570(3)(D), which requires that each ETC file with the Commission a description of its service offerings, and amend such filing as service offerings are introduced or modified, Nexus informs the Commission that it is launching an unlimited talk and text airtime card in Missouri.
- 5. Nexus' Unlimited Airtime Card will have a retail price point of \$45.50. When purchased, the card will provide exactly thirty (30) calendar days of service and will provide unlimited local and domestic long distance calling, and unlimited text messaging. Unlimited Cards can be purchased at any time during the month. Nexus' wireless program is prepaid; as

such, all subscribers will be required to purchase the card prior to obtaining the benefit of the

Unlimited Airtime Card. Once the subscriber loads the Unlimited Card, the subscriber will need

to purchase an additional Unlimited Card and load it on to the subscriber's account within thirty

(30) days from the date the subscriber initially loaded the first Unlimited Card in order to

continue to receive unlimited airtime. Nexus subscribers may add additional money to their

account by purchasing additional airtime cards at participating retail outlets, by making credit

card purchases by calling 611 for free, by calling the Nexus toll free customer care number from

their wireless phone, or on-line at www.Reachoutwireless.com.

WHEREFORE Nexus Communications, Inc., d/b/a Reachout Wireless, pursuant to 4

CSR 240-3.570(3)(D), respectfully informs the Commission that that it is launching an unlimited

talk and text airtime card, as described above, in Missouri.
