SECOND STATUS REPORT

1. On August 10, 2011 (effective August 20, 2011) the Commission issued its Order Approving Application in this case. That Order, among other things, directed as follows:

No later than 30 days after the effective date of this order, if closing on the assets has not occurred, KMB and Liberty ("applicants") shall file a status report with the Commission. If the transfer is not expected to be completed, applicants shall file a pleading with the Commission so stating. Applicants shall file the report or pleading not later than 30 days after the effective date of this order and at the end of each subsequent 30-day period until closing and the transfer of assets is complete.

- 2. Liberty Water previously filed a Status Report on September 19, 2011. The purpose of this Second Status Report is to inform the Commission that as of this date, the transaction that is the subject of this case has not yet closed. However, the parties continue to believe that the transaction will be completed in the near future.
- 3. In accordance with the Order, Liberty Water will notify the Commission no later than five (5) business days after the assets have been transferred or, if the

transaction has not been completed by November 20, 2011, provide another status report to the Commission.

WHEREFORE, Liberty Water respectfully requests that the Commission consider this Second Status Report and, thereafter, issue such orders as it shall find reasonable and just.
