**NOTICE WITHDRAWING MOTION TO EXTEND  
EFFECTIVE DATE OF FIXED BILL PILOT PROGRAM**

COMES NOW Aquila, Inc., d/b/a Aquila Networks-MPS and Aquila Networks-L&P ("Aquila" or the "Company") and states the following:

1. On April 20, 2007, Aquila filed a Motion to Extend Effective Date of Fixed Bill Pilot Program and Filing of Corrected Tariff Sheets (the "Motion"). Paragraphs 2 and 3 of the Motion requested a thirty (30) day extension of the effective date of the *existing* Aquila Networks-L&P division ("L&P") pilot program.
2. After discussions with Staff, Aquila has decided to withdraw its request for the thirty (30) day extension. Instead, Aquila will be making a separate filing addressing an extension of the existing L&P Fixed Bill Pilot Program.
3. This Notice withdrawing the tariff extension request does not affect the Aquila's still-pending request for approval of a *modification* to its Fixed Bill Pilot Program as presented to the Missouri Public Service Commission pursuant to the Company's April 19, 2007 Motion for Approval of a Fixed Bill Pilot Program Tariff which is restated, ratified and confirmed.<sup>1</sup>
