- On April 25, 2011, the Staff of the Commission (Staff) filed Staff's Response to Order.
- 2. The Staff Response recommended that the Commission issue an order that:
 - Rejects MGE's ISRS tariff sheet filing (JG-2011-0433) filed by MGE on February 22, 2011;
 - Approves the Staff's determination of the ISRS surcharge revenue in the amount of annual pre-tax revenues of \$3,308,062; and,
 - Authorizes MGE to file an ISRS rate for each customer class as reflected in Appendix B.
- 3. Having reviewed the April 25, 2011 Staff Response, MGE hereby notifies the Commission that it accepts, and is in agreement with, the above recommendations and rates. MGE therefore asks that the Commission issue an order as requested by the Staff.
