

NOTICE OF COMPLAINT REDUCTION


Comes now Joint Complainant Mid-Missouri Telephone Company, and hereby places all parties on notice that the Complaint of Mid-Missouri Telephone Company, at paragraph 18 of its December 21, 1999 Complaint, should be reduced in the amount of \$8,132.75, representing the amount of the Complaint representing the unpaid terminating cellular access bill for US Cellular.

On or about January 14, Mid-Missouri Telephone Company received a check from US Cellular, a copy of which is attached hereto and incorporated by reference as if set forth herein. US Cellular had previously requested an interconnection agreement with Mid-Missouri Telephone Company, but in those negotiations US Cellular agreed that it was still responsible to pay terminating access to Mid-Missouri Telephone Company for traffic terminated over an indirect interconnection, or transited via Southwestern Telephone Company. After US Cellular dropped its interconnection request, it thereupon made payment of the outstanding bills for terminating access, as reflected in the attached check.

WHEREFORE, all parties are hereby notified that the Complaint of Mid-Missouri Telephone Company against Southwestern Bell for its secondary liability should be reduced in the amount of \$8,132.75.


