**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Lincoln County Sewer & Water, LLC (LCSW), and, in accordance with Missouri Public Service Commission (Commission) Rules 4 CSR 240-2.080(14) and 4 CSR 240-2.065(2), moves the Commission for expedited treatment of LCSW's tariff sheets filed on July 30, 2014:


1. On April 2, 2014, the Commission issued its Report and Order. In that Order, the Commission ordered LCSW to file tariffs consistent with the Report and Order. Later, on July 23, 2014, the Commission issued its Order Regarding Motion to Establish Rate Case Expense.
2. Concurrently, with the filing of this Motion, LCSW has filed tariff sheets in order to comply with the Commission Order (copies of which are provided as **Appendix A**). These tariff sheets carry a proposed effective date of September 1, 2014, and were assigned tracking numbers YW-2015-0035 and YS-2015-0036.
3. LCSW seeks the Commission's order allowing the proposed tariff sheet to go into effect on August 19, 2014.
4. LCSW filed the rate case requests that form the basis for this case on December 4, 2012. The Commission conducted an evidentiary hearing on November 5, 2013. Briefs were filed by the parties on November 26, 2013. The utility plant investment that caused LCSW to make this rate case filing has been in service for

approximately twenty-four (24) months. The Commission's Report and Order has authorized a rate increase for LCSW. Granting this Motion will avoid further delay in regard to the rate relief which the Commission has found to be justified. As such, Commission action as requested will be consistent with the public interest as established by the General Assembly and Commission order.

5. The subject tariff sheets and this Motion have been filed as soon as possible after the issuance of the Commission's Order Regarding Motion to Establish Rate Case Expense.

WHEREFORE, for the foregoing reasons, LCSW respectfully requests the Commission to grant LCSW's Motion for Expedited Treatment and approve LCSW's proposed tariff sheets (Tracking Nos. YW-2015-0035 and YS-2015-0036) to be effective on August 19, 2014.


