

ORDER CANCELING CERTIFICATE AND TARIFF

On January 11, 2000, SeTel, L.L.C. (SeTel), filed its application to surrender its certificate of service authority. SeTel's certificate was issued in Case No. TA-97-503, authorizing SeTel to provide competitive intrastate exchange telecommunication services within the state of Missouri. SeTel states that it has ceased all telecommunications services within the state and that it has no customers in Missouri.

The Staff of the Missouri Public Service Commission (Staff) filed its recommendation on January 21, 2000. Staff stated that because SeTel has no customers in Missouri, surrender of the certificate of service authority is not detrimental to the public interest. Staff further recommended that SeTel's tariff must also be canceled. Staff was not aware of any other filing which affects or which would be affected by this surrender.

The Commission finds that the certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications services granted to SeTel in case number TA-97-503 shall be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of authority and tariffs granted in case number TA-97-503 to SeTel, L.L.C., shall be canceled on February 14, 2000, unless otherwise ordered by the Commission.
2. That this order shall become effective on February 14, 2000.
3. That this case may be closed on February 15, 2000.
