

**ORDER GRANTING RECONSIDERATION OF HOLWAY  
TELEPHONE COMPANY'S THIRD REQUEST  
FOR EXTENSION OF TIME TO FILE ANNUAL REPORT**

On August 15, 2000, the Commission issued its Order Denying Holway Telephone Company's Third Request For Extension Of Time To File Annual Report and Order to Show Cause. On August 16, 2000, Holway Telephone Company (Holway) filed its Response to Commission Order to Show Cause.

In its response, Holway stated that it had filed its annual report on June 15, 2000, and provided a copy of the cover letter and first page of the annual report stamped "Filed." The cover letter and the annual report did not contain a reference to the case in which a request for extension of time to file had been requested. However, the Commission will grant Holway's request for reconsideration of the Commission's order denying Holway's Third Request for Extension of Time to File Annual Report. The Commission finds that there is sufficient cause stated in Holway's Third Request for Extension of Time to File Annual Report to grant its request. Therefore, the Commission finds that Holway's request for extension of time to file annual report shall be granted and Holway's annual report will be accepted as filed June 15, 2000.

The Commission accepts Holway's response filed August 16, 2000 as in compliance with the Commission's order issued August and this case may be closed.

**IT IS THEREFORE ORDERED:**

1. That Holway's request for reconsideration of the Commission's order denying Holway's Third Request for Extension of Time to File Annual Report filed on August 16, 2000 is granted.

2. That Holway Telephone Company's Third Request for Extension of Time to File Annual Report filed on May 30, 2000, is granted and Holway's annual report will be accepted as filed June 15, 2000.

3. That this order shall become effective on September 12, 2000.

4. That this order may be closed after September 13, 2000.
