## <u>REVISED APPENDIX A</u> <u>TO THE UNANIMOUS STIPULATION AND AGREEMENT</u>

**COME NOW** Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company), the Staff of the Missouri Public Service Commission (Staff), the Office of the Public Counsel (Public Counsel) and the Missouri Department of Natural Resources (MDNR), and hereby respectfully state as follows to Missouri Public Service Commission (Commission) in regard to the Revised Appendix A to the Unanimous Stipulation and Agreement:

1. On this date, the referenced parties filed a Unanimous Stipulation and Agreement (Stipulation) in this matter.

2. It was subsequently discovered that Appendix A (Billing Determinants) to the Stipulation had an error. The Standard Transportation Volumes 0 - 7,000 Ccf were inaccurately stated on Appendix A to the Stipulation. This also had an impact on the total volumes for Standard Transportation, but had no impact on any other customer classification.

3. Accordingly, the parties provide the attached Revised Appendix A, which accurately states the Standard Transportation Volumes and ask that it be substituted for the original Appendix A.

**WHEREFORE**, the undersigned Parties respectfully request that the Commission issue its Order approving all of the specific terms and conditions of the Unanimous Stipulation and

Agreement, as revised herein.
