**MGE’S EXTENSION OF
PROPOSED EFFECTIVE DATE**

COMES NOW Missouri Gas Energy, a division of Southern Union Company (MGE), and respectfully states the following to the Missouri Public Service Commission (Commission):

1. On May 15, 2008, MGE proposed a revised tariff sheet P.S.C. MO. No. 1, Third Revised Sheet No. 61.2, Cancelling Second Revised Sheet No. 61.2. The proposed effective date was June 15, 2008.

2. On June 13, 2008, the Commission issued its Order Suspending Tariff and Directing Filing. That Order suspended the tariff sheet until June 22, 2008.


3. On June 19, 2008, the Commission issued its Order Suspending Tariff, wherein it suspended the proposed tariff sheet until June 27, 2008, “to allow additional communication between Missouri Gas Energy and the Midwest Gas Users’ Association.”

4. MGE believes that additional time would be of assistance in regard to this tariff matter. Thus, MGE voluntarily extends the effective date of the subject tariff sheet until July 26, 2008.

WHEREFORE, MGE respectfully requests that the Commission consider the proposed effective date of tariff sheet P.S.C. MO. No. 1, Third Revised Sheet No. 61.2, Canceling P.S.C.

MO. No. 1, Second Revised Sheet No. 61.2, to be extended until July 26, 2008.
