- 1. In its <u>Order</u>, the Commission states that it "will also direct CenturyTel to file a pleading with the details of the calling plan it is offering as discussed at the local public hearing and the status conference. CenturyTel's pleading should outline the specifics of the plan including the rates charged and the terms and conditions of the plan." (<u>Order</u> at 2). Ordered Pargraph 4 provides as follows: "No later than February 14, 2006, CenturyTel of Missouri, LLC, shall file a pleading detailing its new calling plan being offered in the Foley, Marthasville, Warrenton, and Wright City exchanges." (*Id.* at 3).
- 2. CenturyTel is offering its "Simple Choice Bundles" optional calling plan to residential customers in the above-referenced exchanges pursuant to its existing promotional tariff at the rate of \$39.95 per month¹. The primary components of the "Simple Choice/Unlimited Long Distance" \$39.95 per month bundle include: R1 Access line; EAS and/or ECC (where applicable); Simple Choice (with choice of 18 calling

features); VoiceMail; Metro Calling (where applicable); and Unlimited Long Distance (data calls billed at 10 cents per minute).
