**CENTURYTEL’S JOINT MOTION FOR COMMISSION TO ADOPT ORDER
GRANTING CENTURYTEL’S JOINT MOTION FOR SUMMARY DETERMINATION
AND
DENYING SOCKET TELECOM’S CROSS MOTION FOR SUMMARY
DETERMINATION**

CenturyTel of Missouri, LLC (“CenturyTel of Missouri”) and Spectra Communications Group, LLC, d/b/a CenturyTel (“Spectra”),¹ pursuant to the Commission’s Order Directing Parties to File Proposed Orders (“Order Directing Filing”), issued July 23, 2008, jointly file this Joint Motion for Commission to Adopt Order Granting CenturyTel’s Joint Motion for Summary Determination and Denying Socket Telecom’s Cross Motion for Summary Determination.

Pursuant to the Commission’s Order Directing Filing, CenturyTel submits this motion requesting that the Commission adopt CenturyTel’s Proposed Order, which is attached hereto as Exhibit 1.
