

NOTICE OF DISMISSAL


COMES NOW Trigen-Kansas City Energy Corporation ("Trigen"), pursuant to 4 CSR 240-2.116, and for its Notice of Dismissal respectfully states as follows:

1. On July 9, 1999, Trigen filed its Application for Rehearing of the Commission's Assessment Order (Supplemental Order No. 53), which initiated this proceeding.
2. On December 21, 2000, the Commission issued an Order Setting Prehearing Conference in this case. Pursuant to this order, the parties met for a prehearing conference on January 2, 2001.
3. No prepared testimony has been filed in this case, nor has any oral evidence been offered. Therefore, pursuant to 4 CSR 240-2.116, Trigen, as the applicant for rehearing, may, and hereby does, voluntarily dismiss its application by filing this Notice of Dismissal. This dismissal is without prejudice to the right of Trigen to seek rehearing of and/or contest any subsequent assessment order(s) of the Commission.

WHEREFORE, Trigen hereby dismisses Case No. HO-2000-20 without prejudice to its right to seek rehearing of and/or contest any subsequent assessment order(s) of the

Commission, and request that the Commission issue an order recognizing such dismissal and closing this case.
