**AMERENUE'S FILING OF COMPLIANCE TARIFFS
AND MOTION FOR EXPEDITED TREATMENT**

COME NOW Union Electric Company, d/b/a AmerenUE (AmerenUE or Company), and for its filing of Compliance Tariffs and its Motion for Expedited Treatment, state as follows:

1. On March 15, 2007, the Missouri Public Service Commission (Commission) issued its Order Approving Stipulation and Agreement. The Order authorized AmerenUE to file tariffs sheets as agreed to in the Stipulation and Agreement.

2. Attachment 1 to this Motion is a Listing and Designation of Revised Tariff Sheets, identifying which tariffs were revised. Attachment 2 to this Motion is the revised tariff sheets containing rate schedules designed to produce an increase in overall Missouri jurisdictional annual gas revenues of \$6.0 million (exclusive of applicable local taxes) for services rendered on or after April 1, 2007. The tariff sheets have an issue date of March 21, 2007, and an effective date of April 20, 2007. However, AmerenUE is requesting Expedited Treatment so that the tariffs may go into effect by April 1, 2007, as allowed by the Commission's Order Approving the Stipulation and Agreement.

3. These tariffs are identical to those attached to the Stipulation and Agreement with the exception of P.S.C. Mo. No. 2, Sheet No. 42.1, with the exception of a few corrections of typographical errors. The second paragraph on Sheet 42.1 has been modified from the version filed with the Stipulation and Agreement to read as follows:

Application for firm system gas service to new General Service sales customers with an annual load exceeding 40,000 Ccf will be granted only if ~~in the Company's sole judgment,~~ sufficient gas supplies, storage availability and/or pipeline capacity exists. If one or more of these parameters are insufficient, customer, at Company's discretion, may be granted service subject to contract arrangements which address only operational and system constraints. Rates charged under such contract arrangements shall be the applicable rates approved by the MPSC and currently in effect. Residential customers are exempt from this condition. ~~The Company shall immediately notify the MPSC Staff and the Office of Public Counsel any time the Company exercises its discretion under this provision.~~ Where, in Company's judgment, firm service can not be granted the Company will immediately provide the MPSC Staff and the Office of the Public Counsel with data to substantiate that one or more of the aforementioned parameters exist. [Last sentence is new language.]

4. AmerenUE requests the Commission approve the attached compliance tariffs on an expedited basis, no later than March 29, 2007, in order to allow the new rates to go into effect on April 1, 2007.

WHEREFORE, AmerenUE asks the Commission to approve the attached compliance tariffs no later than March 29, 2007 so that the new rates may go into effect on April 1, 2007.
