LACLEDE GAS COMPANY'S STATUS REPORT

COMES NOW Laclede Gas Company ("Laclede" or "Company"), and files this Status Report, stating as follows:

- 1. On November 13, 2007, Isabelle Condict ("Ms. Condict" or the "Customer") filed a complaint against Laclede regarding Laclede's reconciliation of an undercharge during a period when the meter at Ms. Condict's home did not register usage. In the Complaint, Ms. Condict made a request that the charge for the period September 19, 2006-May 1, 2007 be based upon her usage from September 19, 2007-May 1, 2008, rather than on her usage from September 19, 2005-May 1, 2006. Ms. Condict maintained that, based on the circumstances at her home, her gas usage during 2006-07 would be more similar to the 2007-08 usage than to the 2005-06 usage.
- 2. In its December 17, 2007 Answer to the Complaint, Laclede reported that Ms. Condict's Winter 2007 gas usage had already begun to show divergence from her 2005-06 usage pattern. Laclede represented that it would gather information over the winter of 2007-08, and based on that information, reduce its charge for the period September 19, 2006-May 1, 2007, if appropriate.

3. On January 7, 2008, the Commission issued its Order Directing Laclede to File a Status Report by May 1, 2008, after the Company had collected usage data for the winter of 2007-08.

4. For the period September 19, 2007-April 21, 2008, Ms. Condict used 949 CCFs (hundred cubic feet) of gas. Adjusting for the slightly warmer winter in 2006-07, as compared to 2007-08, translates to estimated usage for the period September 19, 2006-May 1, 2007 of 928 CCF, a decrease of 18.7% from the usage previously billed by Laclede.

5. In accordance with Ms. Condict's request and Laclede's representation, Laclede proposes to resolve this case by applying a credit of 214 CCF of gas to Ms. Condict's account for the period September 19, 2006-May 1, 2007.

6. If Ms. Condict declines to resolve her complaint on these terms, Laclede requests that the Commission set a prehearing conference and require the filing of a procedural schedule to administer this case.

WHEREFORE, Laclede respectfully requests that the Commission accept this Status Report.
