## STATUS REPORT CONCERNING SEWER TARIFF CONSOLIDATION

**COMES NOW** Missouri-American Water Company (MAWC) and, as its Status Report Concerning Sewer Tariff Consolidation, states as follows to the Missouri Public Service Commission (Commission):

1. Paragraph 13 of the Non-Unanimous Revenue Requirement Stipulation and Agreement,<sup>1</sup> stated as follows:

MAWC, Staff, OPC, and any other interested party, will participate in a sewer tariff workgroup, for the purpose of developing a single sewer tariff document that will replace current MAWC sewer tariffs and be applied to any future MAWC sewer service area. The first meeting shall occur within 30 days of the effective date of the Commission's order in this case and the workgroup will adopt a goal of finalizing a tariff document that can be filed for Commission approval not later than 180 days after the effective date of the Commission's order in this case, or as soon thereafter as possible. If the workgroup does not complete a consolidated tariff document by this date, it will submit status reports to the Commission within 10 days after this date, and after each 30 day period thereafter.

2. MAWC has met with interested parties to discuss the sewer tariff consolidation, prepared draft consolidated sewer tariffs, and circulated those for comment. However, this project has not yet finalized a tariff document. Thus, in accordance with Paragraph 13 cited above, MAWC provides this Status Report to the Commission and will continue to do so every 30 days until a tariff document has been finalized.

**WHEREFORE**, MAWC requests the Commission consider this filing to comply the requirement to file a status report, and grant such further relief as the Commission shall find to be reasonable and just.
