NOTICE OF AGREEMENT

COMES NOW Missouri Gas Energy, a division of Southern Union Company (MGE or Applicant), and hereby notifies the Missouri Public Service Commission (Commission) of MGE's Agreement with the Staff Recommendation:

1. On April 20, 2009, the Commission Staff (Staff) filed a Staff Recommendation that described Staff's review of MGE's Application and Petition.
2. The Staff recommended that the Commission issue an order that:
 - Rejects the ISRS tariff sheet (YG-2009-0604) filed by MGE on February 19, 2009;
 - Approves the Staff's determination of the incremental ISRS surcharge revenues in the amount of annual pre-tax revenue increase of \$1,330,304 over existing ISRS rates; and,
 - Authorizes MGE to file an ISRS rate for each customer class as reflected in Appendix B.
3. Having reviewed the April 20, 2009 Staff Recommendation, MGE hereby notifies the Commission that it accepts, and is in agreement with, the above recommendations and rates. MGE asks that the Commission issue an order as requested by the Staff. MGE's agreement with the recommendations and rates, however, should not be interpreted as agreement with all of the underlying methodologies used by the Staff. MGE reserves the opportunity to

challenge those methodologies in future cases if differences should become material.

WHEREFORE, MGE respectfully requests that the Commission consider this Notice of Agreement and, thereafter, issue an order consistent with the Staff Recommendation.
