**NOTICE OF CLOSING**



1. The Commission's August 10, 2011, Order Approving Application, among other things, directed that Liberty Water notify the Commission within five (5) business days after the subject assets have been transferred.
2. Liberty Water hereby notifies the Commission that the subject assets were transferred effective November 9, 2011.
3. The Commission's Order further directed that Liberty Water file, within five (5) business days after closing, tariff adoption notice sheets, adopting the water and sewer tariff currently in effect for KMB Utility Corporation.
4. Liberty Water has this date filed the attached tariff sheets (Tracking Nos. YW-2012-0216, YW-2012-0217 and YS-2012-0218) for the purpose of adopting the water and sewer tariffs currently in effect for KMB Utility Corporation.
