

NOTICE

AT&T Missouri,¹ pursuant to the Missouri Public Service Commission's ("Commission's") January 10, 2006 Order,² respectfully notifies the Commission that business service rates in AT&T Missouri's Greenwood exchange increased by \$2.50 as part of the rate increase for business service (flat-rate trunks and multi-line service) in all competitively-classified exchanges.³ Under ordering paragraph five of the Order, the Commission wished to be notified in this case of any MCA rate increase for the Greenwood exchange within two weeks of the effective date of the increase.


