#### SBC MISSOURI'S NOTICE IN REPONSE TO PRESIDING JUDGE'S ORDER

- 1. Dan Joyce and Walt Cecil). On May 5, Staff filed two pages that were inadvertently omitted from Exhibit 5.
- 3. SBC Missouri expresses no opinion on the Staff's Brief, and has no objection to admitting Exhibits 3A, 3B, 3C, 4 and 5 into the record of this case.
