
3. On July 12, 1996, SMCTV filed its Application for a Certificate of Service Authority to provide Intrastate Interexchange and Local Exchange Telecommunications Services to the

Public Within the State of Missouri and for Competitive Classification in Case No. TA-97-19. On August 21, 1996, the Commission issued its Order Approving Interexchange and Local Exchange Telecommunications Services and Order Approving Tariff, which Order became effective on August 26, 1996. SMCTV's tariff became effective on August 26, 1996.

4. The purpose of this Application is to notify the Commission, that, SMCTV has no Missouri intrastate interexchange customers. SMCTV is further notifying the Commission that it no longer intends to conduct business in the State of Missouri after December 31, 1999.

WHEREFORE, Applicant SMCTV, respectfully requests the Commission to cancel its Certificates of Service Authority and Tariffs for interstate interexchange and local exchange service authority approved in Case No. TA-97-19. Further, applicant requests an Order from the Commission with an effective date on or before December 31, 1999.

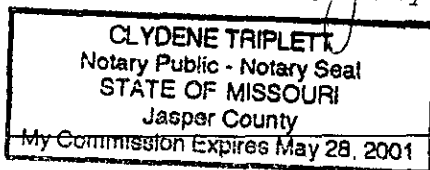

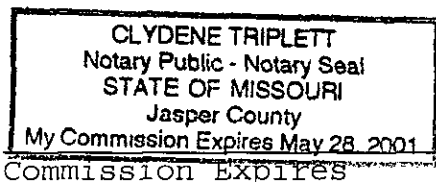


