
COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its



SUBJECT: Supplement to Staff Recommendation

DATE: April 7, 2000

On March 29, 2000, the Telecommunications Department Staff (Staff) filed its recommendation to cancel Socket Internet Services Corporation's (Socket's) certificate of service authority to provide interexchange telecommunications services and the accompanying tariff. On April 4, 2000, the Commission issued its Order Requesting Supplement to Recommendation. The Order directs Staff to supplement its recommendation with conclusions regarding the status of Socket's annual reports and annual assessments. Staff's supplemental filing is due by April 14, 2000.

The Staff contacted Helen Davis in the Commission's Internal Accounting Department and was informed that Socket has no outstanding assessments due. Staff also verified with the Records Department that Socket has filed its annual reports for 1997, 1998 and 1999 and therefore has no annual reports due to the Commission.
