Subject: Delinquent Assessment Payment

Our records indicate that we have not received your payment for the FY-2000 Missouri Public Service Commission assessment. Pursuant to the provisions of 386.370 RSMo Supp. 1999, as a public utility, you are subject to assessment for expenses of the Missouri Public Service Commission. On June 30, 1999, we sent a letter (copy enclosed) showing the amount of your assessment and instructions for payment. The total amount of assessment due by April 15, 2000 is \$16.98. Please make checks payable to the Missouri Director of Revenue and mail to the Missouri Public Service Commission; Attention: Internal Accounting; P.O. Box 360; Jefferson City, MO 65102. If you have already sent your payment, please disregard this notice.

You should be aware that Commission approval of future requests for action filed at the Commission may be conditioned on statement of revenue filings and paid assessments. Also, section 386.570, RSMo 1994, provides for penalties of \$100 per day for failure to comply with Commission orders and requirements. In the most serious cases, the Commission may even order the suspension or revocation of certificates for failure to comply with assessment obligations.

I currently hold a certificate to operate pay phones in Missouri either under the name of PhoneMaster or Paul V. Slatinsky.



Pursuant to the provisions of Section 386.370 RSMo Supp. 1998, you are subject to assessment as a public utility for expenses of the Missouri Public Service Commission. On June 24, 1999, the Commission determined the amount of your assessment by Supplemental Order No. 53 in Docket No. 11,110. A copy of the order is enclosed.
