## **PUBLIC COUNSEL'S POSITION STATEMENT**

Comes Now the Office of the Public Counsel (Public Counsel) and provides its

Position Statement as follows:

1. Is the Application of AmerenUE for permission and authority, that is, a certificate of convenience and necessity, to construct, own, operate and maintain a 345 kilovolt electric transmission line in Maries, Osage, and Pulaski Counties, Missouri in the public interest, and should it be granted, with or without conditions?

<u>Public Counsel</u>: Additional transmission access will benefit the AmerenUE system, but the Commission should also attempt to minimize the impact that the Callaway-Franks Line would have on existing homes and farms. The Application would be in the public interest if, and only if, the Commission can impose reasonable and necessary conditions upon the construction, operation and maintenance of such a transmission line in this area. Such conditions should address the serious concerns raised by the Intervenors.
