- 1. On May 21, 2012, SNGMO filed a Motion for Leave to Amend Application. The purpose of that pleading was to amend SNGMO's Application to reflect certain proposed rates for the subject service area (rather than existing rates, plus a surcharge). The Motion was granted by the Commission on May 24, 2012.
- 2. After further review, it has become apparent that two of the rates included in the Motion for Leave were incorrect. The decimal point in the rates for the "CS Class Commodity Charge" and for "LVS Class Commodity Charge" was misplaced. The following listing of proposed rates corrects that decimal point placement as to the "CS Class Commodity Charge" and the "LVS Class Commodity Charge."

GS Class Customer Charge \$15.00/month

GS Class Commodity Charge \$0.950/CCF

CS Class Customer Charge \$30.00/month

CS Class Commodity Charge \$1.00/CCF

LVS Class Customer Charge \$100.00/month

LVS Class Commodity Charge \$1.00/CCF
