**MOTION TO AMEND APPLICATION  
FOR GEOGRAPHIC PRICING**


COMES NOW Sprint Missouri, Inc. ("Sprint") and requests the Commission allow Sprint to amend its previously filed Application for Geographic Pricing ("Application") removing the Wellington exchange from the Application. Accompanying this Motion is an amended application excluding request for relief in the Wellington exchange and a copy of the proposed amended tariff filing. In support of its Motion, Sprint states as follows:

1. On February 28, 2005 Sprint filed an Application for Geographic Pricing in its Ferrelview, Platte City, Wellington, and Weston exchanges. This Application, in error, requested relief for the Wellington exchange. Moreover, in the initial Application, Sprint requested that the tariff become effective in no more that 45 days with an effective date of April 14, 2005.

WHEREFORE Sprint respectfully requests the Commission grant Sprint's motion and allow the Wellington exchange to be removed from the prior Application. In addition, Sprint requests that the previously requested effective date not be altered as no party will be prejudiced in having the prescribed statutory time evaluate the Sprint Application in the Ferrelview, Platte City and Weston exchanges.
