CENTURYTEL OF MISSOURI, LLC'S MOTION TO DISMISS, ANSWER AND AFFIRMATIVE DEFENSES TO AMENDED COMPLAINT

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel"), pursuant to Commission Rule 4 CSR 240-2.070 and the Commission's *Order Further Modifying Procedural Schedule* issued on February 1, 2005, and for its Motion to Dismiss, Answer and Affirmative Defenses to the Amended Complaint To Enforce Interconnection Agreements filed by MCImetro Access Transmission Services, LLC, Brooks Fiber Communications of Missouri, Inc. and Intermedia Communications, Inc. (collectively "MCI"), respectfully states as follows:

1. On January 12, 2005, MCI filed a motion requesting leave to file an amended complaint. The proposed amended complaint was filed at the same time. The motion explained that since the initial complaint was filed on September 20, 2004, Intermedia Communications has been merged into MCImetro. The motion asked leave to file an amended complaint "to address"

this subsequent development." MCI also stated that in its Amended Complaint, "MCI corrects some minor typographical errors and makes some adjustments to reflect the pleading is an amended complaint rather than the original filing."

- 2. CenturyTel did not oppose MCl's motion and, on January 25, 2005, the Commission issued its *Order Granting Leave To File Amended Complaint*. In addition, by its *Order Further Modifying Procedural Schedule* issued in this matter on February 1, 2005, the Commission modified the procedural schedule herein to provide that the Answer to Amended Complaint be filed by CenturyTel on or before February 22, 2005.
- 3. Accordingly, CenturyTel hereby adopts and incorporates by reference, as if fully set forth herein, its Motion to Dismiss, Answer and Affirmative Defenses previously filed in this matter on November 4, 2004, as its Motion to Dismiss, Answer and Affirmative Defenses to the Amended Complaint. In addition, CenturyTel acknowledges that the Commission issued its *Order Approving Merger and Canceling Certificate and Tariff* in Case No. TM-2005-0129, on January 4, 2005, wherein the Commission finds that "Intermedia has no customers in Missouri, so the merger will have no customer impact. Staff filed its recommendation regarding the application on December 1. Staff confirms that Intermedia has no Missouri customers, so the merger will have no customer impact." ²
