In the matter of the Application of FOXFIRE UTILITY COMPANY, a Missouri corporation, for 1) permission, approval, and a certificate of convenience and necessity authorizing it to construct, install, own, acquire, operate, control, manage, and maintain a water and sewer system for the public located in an unincorporated area in Stone County, Missouri; 2) authority to borrow up to \$400,000 for purposes of acquiring, constructing and installing utility plant and equipment; and 3) authority to place a mortgage on its plant and equipment to secure said loan.

AMENDED APPLICATION

Comes now Foxfire Utility Company (Applicant) and, for its Amended Application, states to the Missouri Public Service Commission (Commission) as follows:

- 1. Applicant is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 312 Lafayette, P. O. Box 7017, Jefferson City, Missouri 65102. A copy of Applicant's Certificate of Incorporation and Articles of Incorporation are attached to its original Application and incorporated herein by reference as Exhibit No. 1. Applicant is a public utility proposing to provide water and sewer service to the public subject to the jurisdiction of this Commission.

- 3. Applicant requests permission, approval, and a certificate of public convenience and necessity to install, own, acquire, construct, operate, control, manage and maintain a water and sewer system for the public in an incorporated area in Stone County, Missouri, as legally described in Revised Exhibit No. 2, attached hereto and incorporated herein by reference. A map of the proposed certificated area is attached to Applicant's original Application and incorporated herein by reference as Exhibit No. 3.
- 4. In accordance with 4 CSR 240-2.060(2)(A)(9), Applicant has prepared a feasibility study which, among other things, contains plans and estimated costs of the utility plant and equipment to be installed; plans for financing; proposed rates and charges; and an estimate of the number of customers, revenues and expenses during the first three years of operation. Said feasibility study is attached to Applicant's original Application and incorporated herein by reference as Exhibit No. 4. In addition, attached hereto and incorporated herein by reference as Exhibit No. 8 is an updated schedule of water and sewer expenses

which Applicant expects to incur in its first years of operation as well as proposed rates necessary to recover said expenses.

- 5. Applicant's proposed certificated area lies within the limits of the Village of Indian Point, Missouri; however, Applicant has been advised that no formal approval of the Village of Indian Point or Stone County is required for Applicant to provide the water and sewer service as proposed.
- 6. There are no other public utilities or governmental entities being operated or rendering water and sewer service within the area proposed to be served.
- 7. Applicant's water and sewer systems will meet all requirements of the Missouri Department of Natural Resources. A copy of the appropriate permits issued by the Missouri Department of Natural Resources are included as an Appendix to the feasibility study (Exhibit No. 4).
- 8. The area requested to be certificated is rapidly being developed into a condominium development immediately south of the Silver Dollar City theme and crafts park. The developer is currently in the final stages of construction of its initial phase of construction of said condominiums. When fully developed, this 50 acre development will contain 89 buildings having six units each for a total of 534 dwelling units. Therefore, a public need exists for adequate water and sewer service within the area proposed to be served and the public convenience and necessity will be promoted by the granting of the authority herein requested.

- 9. Attached to the original Application and incorporated herein by reference as Exhibit No. 5 is a list of the names and addresses of ten residents residing within the proposed certificated area.
- 10. In order to finance a portion of the cost of acquiring, constructing and installing the proposed water and sewer system, Applicant proposes to borrow an amount not to exceed \$400,000. The developer of this area has agreed to loan Applicant up to \$400,000 for a period of ten years with an interest rate of not more than 2% over the Chase Manhattan National Bank prime rate. In order to secure the loan, Applicant will be required to give to the lender a Deed of Trust and Security Agreement on Applicant's machinery, furnitures, fixtures, accounts receivables and inventory. The terms of the loan are evidenced by a loan commitment letter which is attached to the original Application and incorporated herein by reference as Exhibit No. 6.
- 11. The proceeds of the loan will be used by Applicant to purchase, construct, and install part of the water and sewer plant necessary to provide service within the proposed certificated area. None of the purposes to which the proceeds of the loan will be applied are in whole or in part reasonably chargeable to operating expenses or to income.
- 12. A certified copy of the Resolution of the Board of Directors of Applicant authorizing the proposed loan is attached to the original Application and incorporated herein by reference as Exhibit No. 7.

- 13. A balance sheet and income statement, with adjustments, showing the effect of the proposed loan upon the indebtedness and capitalization of Applicant are included in the feasibility study attached to the original Application and incorporated herein by reference as Exhibit No. 4.
- 14. Inasmuch as Applicant is a "start-up" utility company, a five year capitalization expenditure schedule as required by Section 393.200 RSMo. 1986 and 4 CSR 240-2.060(6)(H) is not available.
- 15. The proceeds of the loan are not anticipated to be used for the purpose of guaranteeing, taking over, refunding, discharging or retiring any bond, note or other evidence of indebtedness, therefore, Applicant is of the opinion that the entire amount of the proposed loan will be subject to the fee schedule as set forth in Section 386.300.1(5), RSMo. 1986.
- 16. Commission approval of the proposed loan is in the public interest because this is the most effective and economical manner in which to fund a portion of the acquisition, construction and installation of water and sewer system necessary to provide service within the proposed certificated area.

WHEREFORE, Applicant respectfully requests the Commission to issue its order:

 granting Applicant, permission, approval, and a certificate of public convenience and necessity authorizing it to construct, install, own, acquire, operate, control, manage, and maintain a water and sewer system for the public, within the area referred to in paragraph 3 hereof;

- 2) authorizing Applicant to implement rates and charges for the provision of water and sewer service consistent with those contained in Exhibit No. 8, attached hereto;
- 3) authorizing Applicant to borrow an amount not to exceed \$400,000 and to give as security therefore a Deed of Trust and Security Agreement on Applicant's machinery, equipment, furniture, fixtures, accounts receivables and inventory upon the terms and conditions set forth herein;
- 4) authorizing Applicant to do and perform, or cause to be done and performed, all such other acts and things as well as to make, execute and deliver any and all documents as may be necessary, advisable or proper to the end that the intent and purposes of this borrowing may be fully effectuated;
- 5) finding that the money, property and labor to be procured by said borrowing is reasonably required for the purposes specified herein, and that no part of the proceeds shall be reasonably chargeable to operating expenses or to income; and
- 6) granting such further relief in this matter as the Commission may deem necessary.


