

**AMENDED NOTICE**


COMES NOW Advanced Communications Group, Inc. ("ACG"), by its undersigned counsel, and provides this AMENDED NOTICE to inform the Commission that Feist Long Distance Service, Inc. ("Feist") ceased to be a wholly owned subsidiary of ACG effective November 19, 1999. On that date, ACG transferred control of Feist to Ionex Telecommunications, Inc. ("Ionex") through a stock sale transaction.<sup>1</sup> By this AMENDED NOTICE, ACG clarifies the record in this Case to reflect the fact that Feist ceased to be a wholly owned subsidiary of ACG prior to this Commission's grant of approval of the assignment to Feist of the interconnection agreement between ACG and Southwestern Bell Telephone Co.

<sup>1</sup> By Order effective October 29, 1999, this Commission dismissed the joint application of ACG and Feist for approval of the transfer of control. *In the Matter of the Joint Application of Feist Long Distance Service, Inc., Telecom Resources, Inc. d/b/a TRINetwork, Inc., and Advanced Communications Group, Inc., for Approval of Transfers of Control*, Case No. TM-2000-146.


