SUPPLEMENTAL INFORMATION IN SUPPORT OF APPLICATION

COMES NOW Union Electric Company d/b/a AmerenUE (“Applicant”), and in support of its previously filed Application for permission and authority to issue and sell up to \$314,000,000 aggregate principal amount of additional long-term indebtedness (“New Indebtedness”), respectfully provides the following supplemental information:

1. On April 29, 2008, Applicant filed an Application for authority to issue and sell up to \$314,000,000 aggregate principal amount of New Indebtedness.
2. The Application did not include Applicant’s financial statements and capitalization ratios but rather indicated that such information would be provided as soon as it became available.
3. Attached as Schedule 1 to this pleading are Applicant’s financial statements as of March 31, 2008, as specified in 4CSR 240-3.120 (1) (E), and the capitalization ratios as of the same date, including such ratios after giving effect to the proposed transactions.

WHEREFORE, Applicant respectfully requests the Commission to issue its order:

- (i) Authorizing Applicant to issue and sell up to \$314,000,000 aggregate principal amount of New Indebtedness, as set forth in its

Application filed on April 29, 2008, as supplemented herein, at any time after the effective date of the order or orders;

- (ii) authorizing Applicant to enter into, execute, deliver and perform the necessary agreements, indentures, notes and other documents relative to the New Indebtedness;
- (iii) authorizing Applicant to do any and all other things not contrary to law or the rules and regulations of the Commission, incidental, necessary or appropriate to the performance of any and all acts specifically to be authorized in such order or orders; and
- (iv) containing such other provisions as the Commission may deem just and proper.


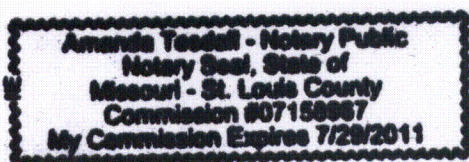
