COME NOW, Sprint Missouri, Inc. (Sprint Local) and Sprint Communications Company L.P. (Sprint Long Distance), collectively referred to as "Sprint," and pursuant to Section 386.420 RSMo and 4 CSR 240-2.110 respectfully seek an Order granting intervention into the above referenced proceeding. In support, Sprint states as follows:

WHEREFORE, Sprint respectfully requests the Commission to issue an Order

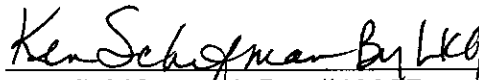
