## Application to Intervene of the Missouri Independent Telephone Group

The Missouri Independent Telephone Group of local exchange companies, Alma Telephone Company, Chariton Valley Telephone Corporation, Choctaw Telephone Company, Mid-Missouri Telephone Company, Modern Telecommunications Company, MoKan Dial Inc., and Northeast Missouri Rural Telephone Company, hereinafter referred to as the Missouri Independent Telephone Group, hereby applies to intervene in this proceeding. In support of this Application the Missouri Independent Telephone Group states as follows:

- 2. The Missouri Independent Telephone Group consists of seven certificated local exchange companies providing local and exchange access services in their respective certificated exchanges. The Missouri Independent Telephone Group companies are also rural telephone companies under the Telecommunications Act of 1996, and small incumbent local exchange telecommunications companies under the provision of 1996 SB 507.



3. In its January 19, 2000, Order and Notice of Petition, the Commission has notified interested parties that on December 17, 1999, the North American Numbering Plan Administrator NeuStar, Inc. (NANPA) filed a pleading requesting that the Commission approve "retroactive" all services overlay relief plan for the 314 Numbering Plan Area (NPA) and a single all services overlay relief plan for the 816 NPA. At the

request of the Office of Public Counsel an intervention period was established that

expires on February 4, 2000.

4. Although the Missouri Independent Telephone Group does not have

exchanges in the 314 and 816 area code, the issues presented in this proceeding may have

a presidential impact on the development of overlay plans as they pertain to area codes

statewide. Furthermore, Missouri Independent Telephone Group's expertise in and

perspective on the condition of telecommunications services in this State will aid the

Commission in resolving the issues related to this proceeding. Accordingly, Missouri

Independent Telephone Group's intervention and participation will serve the public

interest.

that it be allowed to intervene and participate fully herein as parties.
