

COMES NOW Nextlink Missouri, Inc., ("Nextlink") by and through counsel, and pursuant to 4 CSR 240-2.075(4) respectfully requests that the Commission permit it to intervene in the captioned cause. In support thereof, Nextlink submits the following:

1. Nextlink is a telecommunications company under the jurisdiction of this Commission. It acquired certificate of service authority to provide intrastate interexchange services in Case No. TA-99-220, and to provide basic exchange and local exchange telecommunication services in Case No. TA-99-48.

3. On December 17, 1999, The North American Numbering Plan Administrator NeuStar, Inc. filed a pleading requesting that the Commission approve a "retroactive" all services overlay relief plan for the 314 Numbering Plan Area (NPA) and a single all services overlay relief

plan for the 816 NPA.

4. On January 5, 2000, the Commission entered its Order and Notice of Petition setting out therein an intervention deadline of February 4, 2000. This application is timely.


5. Nextlink is authorized to offer and provide service in all of Southwestern Bell Telephone Company's exchanges and it has operations within the 314 NPA. The outcome of this proceeding will have a direct impact on Nextlink. Therefore, it has an interest herein that is different from that of the general public.

6. At this time Nextlink does not have a position respecting the relief requested by the numbering plan administrator.

7. Nextlink's intervention in this proceeding will benefit the Commission in deciding the issues. Nextlink can supply the Commission with the viewpoint of an emerging competitive local exchange carrier with respect to the issues under consideration. Its intervention will serve the public interest.


