MOTION FOR EXPEDITED TREATMENT

Comes now Aquila, Inc. d/b/a Aquila Networks and Aquila Networks - L&P ("Aquila"), in accordance with Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.080(16), and, as its Motion for Expedited Treatment, states to the Commission as follows:

1. With this Motion, Aquila is filing the following tariff sheets related to the line extension policy for Aquila's Aquila Network - L&P service territory (copies attached):

P.S.C. Mo. No. 1, 1st Revised Sheet No. R-2, canceling P.S.C. Mo. No. 1, Original Sheet No. R-2; and,

P.S.C. Mo. No. 1, 1st Revised Sheet No. R-54, canceling P.S.C. Mo. No. 1, Original Sheet No. R-54.

These tariff sheets contain an issue date of April 23, 2004, and an effective date of May 23, 2004.

2. This change is being made in order to establish an approximately six month phase-in period for the new line extension policy that will apply to the Aquila Networks - L&P service area. Aquila believes such a phase-in of the new policy will provide time to inform customers of the change, educate customers as to the requirements and allow builders and developers time to include these changes in their cost estimates and contracts. A similar phase-in period was used when the Aquila Networks - MPS service area first implemented the line extension policy that will now apply


to the Aquila Networks - L&P service area.

3. Because the subject tariff sheets now carry an effective date of May 23, 2004, Aquila seeks to reduce the length of time before the phase-in period available. To that end, Aquila asks that the tariff sheets become effective on May 5, 2004.

4. The grant of this motion may have a positive benefit for Aquila's customers in that it will provide a transition period from the line extension policy formerly applicable to the Aquila Networks - L&P service area to the new policy. This Motion has been filed as soon as possible after establishment of the new policy.

WHEREFORE, for all the foregoing reasons, Aquila, Inc. d/b/a Aquila Networks and Aquila Networks - L&P respectfully requests the Commission to consider this Motion for Expedited Treatment and to approve the proposed tariff sheets effective May 5, 2004.
