#### ORDER CANCELING CERTIFICATE

On November 29, 1999, Southwest Missouri Cable TV, Inc. (SMCTV) filed its application for cancellation of certificate and tariff, asking the Missouri Public Service Commission (Commission) to cancel its certificate of service authority and tariff for "basic local telecommunications (sic)." In fact, however, on August 26, 1996, in case number TA-97-19, the Commission entered its order granting SMCTV a certificate of service authority to provide intrastate interexchange telecommunications services and granting a certificate of service authority to provide local exchange telecommunications services. The order also approved SMCTV's tariff which went into effect the same day.

SMCTV stated in its application that SMCTV has no Missouri intrastate interexchange customers. SMCTV stated that it is further notifying the Commission that it no longer intends to conduct business in the state of Missouri after December 31, 1999.

Section 392.410(5) RSMo states, in part, that "...[a]ny certificate of service authority may be altered or modified by the

commission after notice and hearing, upon its own motion or upon application of the person or company affected...."

The Commission has reviewed the application and the official file and finds that the Certificates of Service Authority granted to SMCTV in case number TA-97-19 shall be canceled.

#### IT IS THEREFORE ORDERED:

- 1. That the certificates of authority granted and tariffs approved in case number TA-97-19 for Southwest Missouri Cable TV, Inc. shall be canceled on December 13, 1999, unless otherwise ordered by the Missouri Public Service Commission.
  - 2. That this case may be closed on December 14, 1999.
