

ORDER GRANTING REQUEST FOR APPROVAL OF FILING

On September 11, 1986, the Kansas City Power & Light Company (KCPL) filed a motion requesting that the Commission approve KCPL's proposed form of filing its direct testimony and exhibits as complying with the minimum filing requirements as ordered by the Commission.

In support of its request KCPL states that the Commission's Order dated August 25, 1986, directed KCPL to file its direct testimony and schedules and "minimum filing requirements" on or before October 3, 1986.

KCPL states there is no regulatory provision making minimum filing requirements applicable to steam rate cases. KCPL states that it has held discussions with the Staff regarding the kinds of information the Staff wishes to see in the Company's initial filing. It is KCPL's understanding that Staff wishes KCPL to provide the same kinds of information that KCPL included in its testimony and exhibit filing in Case No. HR-83-243, KCPL's last steam rate case.

KCPL proposes to file on or before October 3, 1986, direct testimony and exhibits which include, among other things, the kinds of information KCPL furnished in its initial filing in Case No. HR-83-243.

Having reviewed the Company's request, the Commission concludes that it is reasonable and should be granted.

It is, therefore,

ORDERED: 1. That KCPL's proposed form of filing direct testimony and exhibits as set forth in its "Request For Approval Of Filing" filed on September 11, 1986, be, and it is, hereby approved as complying with the procedural requirement of filing its "prepared direct testimony and schedules and minimum filing requirements" as set forth in the Commission's order dated August 25, 1986.

ORDERED: 2. That this Order shall become effective on the date hereof.

Dear Mr. Hubbs:

Pursuant to the Commission's June 27 Order in this matter, please find enclosed for filing four copies each of (i) Revised Rate Schedules of increased steam service rates, (ii) as an alternative thereto, Phase-in Rate Schedules of increased steam service rates, (iii) a Conversion Schedule dividing KCPL's steam service territory into various distribution areas and assigning a date certain to each area when steam service from Grand Avenue Station will no longer be required to be provided, and (iv) revised General Rules and Regulations Applying to Steam Service. The schedules of rates and general rules and regulations are identical to those filed by KCPL on June 2, except that each now bears an issue date of July 7, 1986, and a proposed effective date of January 1, 1987. The enclosed Conversion Schedule differs from the one transmitted to the Commission on June 16 in that it now bears an issue date of July 7, 1986, and a proposed effective date of January 1, 1987, and the proposed conversion date for areas 1 through 4 has been changed from July 1, 1986, to January 1, 1987.

KCPL respectfully requests the Commission to issue, at its earliest convenience, a procedural schedule on this matter. KCPL has received several questions regarding the status of its steam service plan from certain of its customers who are now contemplating heating source options. It is thus in the best interests of KCPL's steam customers for the questions concerning future steam service conditions and rates be resolved as expeditiously as possible, so that they will be able to make informed decisions on the method of meeting their heating needs in the coming years.
