ORDER SHORTENING TIME FOR RESPONSE

On July 23, 1999, GST Steel Company (GST) filed its Motion to Compel Kansas City Power & Light Company (KCPL) to Respond to GST's Second and Third Sets of Interrogatories and Requests for Production of Documents. Pending is GST's first motion to compel. In view of the expedited procedural schedule adopted herein and the danger of significant delay due to discovery disputes, KCPL will file its response to GST's motion, if any, on or before July 30, 1999.

IT IS THEREFORE ORDERED:

1. That Kansas City Power & Light Company shall file its response to GST Steel Company's Motion to Compel KCPL to Respond to GST's Second and Third Sets of Interrogatories and Requests for Production of Documents on or before July 30, 1999.


