ORDER DIRECTING FILING

The transcript having been filed herein on April 25, 2000, the Commission establishes the briefing schedule herein set out. The parties agreed at the close of the hearing to the following: initial briefs by May 12, 2000, and reply briefs by May 24, 2000. As announced at the close of the hearing, the Commission shall require the parties to submit proposed findings of fact and conclusions of law simultaneously with their initial briefs.

IT IS THEREFORE ORDERED:

1. That the parties may file their initial briefs herein on or before 3:00 p.m. on May 12, 2000, and may file their reply briefs herein on or before 3:00 p.m. on May 24, 2000. Initial briefs shall not exceed 30 pages; reply briefs shall not exceed 15 pages.

2. That each party shall file proposed findings of fact and • conclusions of law on or before 3:00 p.m. on May 12, 2000. These shall be embodied in a separate document from the brief, if one is filed. Each proposed finding of fact shall contain appropriate references to the record showing where supporting evidence is to be found, legally sufficient to permit the Commission to find the proposed fact. Each proposed conclusion of law shall contain appropriate citations to statutory or other authority. Proposed findings of fact and conclusions of law shall not exceed 50 pages.

3. That any motion directed at a party's briefs or proposed findings of fact and conclusions of law shall be filed not later than the tenth day following the filing of the brief or proposed findings of fact and conclusions of law with which it is concerned.

4. That this order shall become effective on May 10, 2000.


