

ORDER GRANTING EXTENSION OF TIME

On January 12, 2001, the Staff of the Missouri Public Service Commission filed a Joint Request for Extension of Time, requesting an extension from January 12, 2001, to January 26, 2001, to file certain responses and reports pursuant to an order of the Commission issued on November 21, 2000. The Terre Du Lac Utilities Corporation and the Office of the Public Counsel also had certain filing requirements under the order. Staff's request was on the behalf of all the parties. Staff's request related that these filings were interrelated and that extending the date of filing would facilitate preparation of the required reports and responses.
