ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF

On December 1, 1999, London Telecom Network, Corp. (LTN), filed a letter requesting recognition of a name change, a revised tariff incorporating the name change, and documentation to show a name change, registered with the Secretary of State, to show its change of name to TransWorld Network, Corp. (TWN). The requested effective date for the tariff is January 2, 2000. TWN was authorized to provide intrastate interexchange telecommunications services in the State of Missouri pursuant to the Commission's July 26, 1993, Order in Case No. TA-93-299. This is TWN's second name change. It was originally certificated as Strategic Alliances, Inc.

The Commission's Staff reviewed the application and filed a Staff Recommendation and Memorandum on December 21, 1999. Staff stated that Staff has no objection to the proposed name change and recommends the Commission amend TWN's certificate of service authority to reflect the new company name and approve the following tariff pages to become effective January 2, 2000: TransWorld Network, Corp. P.S.C. MO. No. 1, Original Page No. 1 through Original Page No. 30.

The Commission has reviewed the application, the tariff and Staff's recommendation and finds that the change of corporate name should be recognized and that the tariff should be approved to become effective on January 2, 2000.

IT IS THEREFORE ORDERED:

1. That the change of name for TransWorld Network, Corp., formerly London Telecom Network, Corp., is recognized.
2. That the tariff filed by TransWorld Network, Corp., formerly London Telecom Network, Corp., on December 1, 1999, Tariff File No. 200000517, is approved to become effective on January 2, 2000. The tariff approved is:
