ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

On March 5, 1998, the Commission issued an Order Granting Certificate of Convenience and Necessity to Osage Water Company (OWC or Company) for authority to install, own, operate and maintain a water and sewer system in an unincorporated area of Camden County known as "Cimmarron Bay." On March 10 OWC filed tariff sheets to comply with the Commission's order. On March 17 and March 30 the Company filed substitute tariff sheets. The tariff sheets bear an effective date of April 11.

On April 3 the Staff of the Commission (Staff) filed a memorandum which indicated that the tariff sheets filed by OWC are in compliance with the Commission's order. Staff recommended that the Commission issue an order approving the tariff sheets.

The Commission has reviewed the tariff sheets filed by OWC and the Staff's memorandum. The Commission finds that the tariff sheets filed by OWC on March 10, as substituted on March 17 and March 30, are in compliance with the Commission's order.

IT IS THEREFORE ORDERED:

1. That the following water service tariff sheets filed by Osage Water Company on March 10, 1998, as substituted on March 17, 1998, and March 30, 1998, are approved and shall become effective for service rendered on and after April 11, 1998:
