ORDER RECOGNIZING CHANGE OF CORPORATE NAME AND APPROVING ADOPTION NOTICE

ACI Corp. (ACI) submitted an adoption notice on September 3, 1999, designed to reflect that it has changed its corporate name to Rhythms Links Inc. (Rhythms). ACI stated in the cover letter with its filing that ACI has not yet filed its tariff¹. ACI stated that the revised title page is part of a tariff submission, but since the tariff has not yet been filed, the new corporate name will not be shown until the tariff is filed. ACI stated that an adoption notice was enclosed which would be part of a tariff submission. Also included with its filing is ACI's amended certificate of authority from the Missouri Secretary of State, dated July 19, 1999, showing the new name, Rhythms Links Inc.

The Staff of the Commission (Staff) filed a memorandum on September 24, 1999, stating that it had reviewed ACI's filing and

adoption notice and that Staff had no objection to their approval. Staff also noted that ACI has not yet filed an interconnection agreement or original tariff that could be adopted by Rhythms.

The Commission has reviewed ACI's filing, the adoption notice, and Staff's recommendation, and finds that the change of name should be recognized. The Commission further finds that the adoption notice reflecting the change of name should be acknowledged.

IT IS THEREFORE ORDERED:

- 1. That the change of name from ACI Corp. to Rhythms Links Inc. is acknowledged.
- 2. That the adoption notice denominated as Original Adoption Notice Page is approved.
 - 3. That this order shall become effective on October 8, 1999.
 - 4. That this case may be closed on October 9, 1999.
