ORDER DIRECTING FILING

On April 28, 2000, J D Services, Inc. (J D Services or Applicant), a Nevada Corporation, filed an application requesting a certificate of service authority to provide interexchange telecommunications services, requesting competitive status, and requesting waiver of certain statutes and rules. J D Services states that it is merging with a Utah corporation that uses a similar name and has concurrently filed an Application for Merger Approval. That application has been assigned Case No. TM-2000-699. The Applicant will be the surviving corporate entity and proposes to adopt the tariff of the company with which it is merging.

On May 5, 2000, the Commission issued an Order Requiring Filing of a First Amended Application. J D Services filed its First Amended Application on May 17, 2000. The Commission published its Schedule of Applicants on May 9, 2000, and established an intervention date of May 24, 2000, for this case. No applications to intervene have been filed.

To assure the prompt resolution of the application, the Commission will set a filing date for a report from the Commission's

Staff presenting the status of this case or for a Staff recommendation.

IT IS THEREFORE ORDERED:

1. That the Staff of the Missouri Public Service Commission shall file, no later than 3:00 p.m. on June 26, 2000, a status report or its recommendation regarding the First Amended Application.

2. That this order shall become effective on June 6, 2000.
