ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

LD Exchange.com, Inc. (LDE.com) applied to the Public Service Commission on May 16, 2000, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994¹. LDE.com asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. LDE.com is a Delaware corporation, with its principal office located at 2510 N. Redhill Avenue, Suite 230, Santa Ana, California 92705-5542.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on May 23, 2000, directing parties wishing to intervene to file their requests by June 7, 2000. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission,
776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked
permission to intervene or requested a hearing, the Commission may
grant the relief requested based on the application.

LDE.com filed a proposed tariff in conjunction with its application and filed substitute sheets on May 26, 2000. The tariff's effective date is June 30, 2000. LDE.com's tariff describes the rates, rules, and regulations it intends to use, identifies LDE.com as a competitive company, and lists the waivers requested. LDE.com intends to provide interexchange telecommunications services including 1+, 800/888/877 Services, Directory Assistance, Debit Card, and Travel Card services.

In its Memorandum filed on June 19, 2000, the Staff of the Commission (Staff) recommended that the Commission grant LDE.com a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on June 30, 2000.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and LDE.com should be granted a certificate of service authority. The Commission finds that the services LDE.com proposes to offer are competitive and LDE.com should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that LDE.com's proposed tariff details the services, equipment, and pricing it proposes to offer. The Commission finds that the proposed tariff filed on May 16, 2000 shall be approved as amended to become effective on June 30, 2000.

IT IS THEREFORE ORDERED:

- 1. That LD Exchange.com, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That LD Exchange.com, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
