ORDER EXTENDING TIME TO FILE ANNUAL REPORT

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On April 28, 2000, Holway Telephone Company (Holway) requested an extension of time to file its 1999 annual report. Holway stated that it has made a diligent effort to complete the report for submission by April 15; however, it was not able to do so because of changes in sources of the company's revenue and its accounting made necessary by the elimination of the primary toll carrier plan and the institution of dialing parity in its exchanges. Holway requested an extension up to May 15, 2000 in which to complete and file its annual report. No objections to Holway's request were received.

On May 15, 2000, Holway requested an additional 15 days extension to file its annual report. Holway stated that it had been diligently trying to meet its requested deadline of May 15, 2000, but it had been unable to do so. Holway requested an extension of time up to May 30, 2000.



The Commission finds good cause for Holway's failure to timely comply with Commission Rule 4 CSR 240-10.080(1) and shall grant Holway an extension of time to file its annual report.

IT IS THEREFORE ORDERED:

- 1. That Holway Telephone Company's Request for Extension of Time to File Annual Report filed April 28, 2000, and supplemented May 15, 2000, is granted, and Holway Telephone Company shall file its annual report no later than May 30, 2000.
 - 2. That this order shall become effective on June 12, 2000.
