ORDER GRANTING MOTION TO FILE ANNUAL REPORTS OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]11 public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 5, 2000, Steelville Telephone Exchange, Inc., and Steelville Long Distance, Inc. (collectively referred to as Steelville), filed a Motion for Leave to File Annual Reports Out of Time. Steelville requested that its 1999 annual reports, which were filed along with its motion, be accepted for filing out of time. Steelville noted that on April 12, 2000. The basis for Steelville's request was that it had recently experienced a change in management which, combined with difficulties in completing its audit, caused the preparation of its annual report to take more time than anticipated. Steelville requested an extra 15 days, up to April 30, in which to file its annual reports.

Steelville submitted its annual reports before the requested extension date of April 30, 2000, but the reports were returned with the notation that the reports should be submitted with a motion

requesting additional time. Steelville subsequently filed its Motion for Leave to File Annual Reports Out of Time.

The Commission finds that good cause exists to permit Steelville to file its annual reports out of time, and the Commission will grant the company's Motion for Leave to File Annual Reports Out of Time.

IT IS THEREFORE ORDERED:

- 1. That the Motion for Leave to File Annual Reports Out of Time, filed May 5, 2000, by Steelville Telephone Exchange, Inc., and Steelville Long Distance, Inc., is granted. The annual report dead-line requirement of 4 CSR 240-10.080 is waived, permitting the filing of the 1999 annual reports of Steelville Telephone Exchange, Inc., and Steelville Long Distance, Inc., on May 5, 2000.
 - 2. That this order shall become effective on June 13, 2000.
 - That this case may be closed on June 14, 2000.
